	The Contractor shall allow for protection and support of all works which may be affected by the demolition works and subsequent reconstruction.		
	Demolition work generally shall be carried out in such manner that there will be a minimum of inconvience to adjoining owners, the public and existing occupants. The safety of the adjoining buildings and the public shall be a paramount importance during the execution of the demolition work and all necessary precaution shall be taken. The Contractor will be held responsible and is to indemnify the building owner for any claim or series of claims which may arise out of the demolition work.		
	All materials arising out of demolition and alteration are to become the property of the Contractor and to be removed from the buildings and cleared away from the site as directed by the S.O.		
	The prices for demolition work are to include for providing, erecting and removing on complete to the satisfaction of the S.O all necessary shoring, needling, and strutting, watering plaster work and rubbish to lsy the dust, providing dust sheet, tarpaulins, temporary roof covering, water, chutes, screens and other protection necessary to safeguard the existing and adjoining works, clearing away all rubbish and make good all work disturbed.		
	The prices are to include for the use of all necessary scaffolding, ladders, trestles, etc. that may be necessary and for the works and removal of same on completion.
